

**SUMMARY ANNUAL REPORT FOR
AMES CONSTRUCTION BENEFIT PLAN**

This is a summary of the annual report of the AMES CONSTRUCTION BENEFIT PLAN (Employer Identification Number 41-0871375, Plan Number 505) for the plan year 10/01/2024 through 09/30/2025. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

AMES CONSTRUCTION has committed itself to pay certain Health, Prescription drug, Dental, Employee assistance program claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with METROPOLITAN LIFE INSURANCE COMPANY and VISION SERVICE PLAN to pay certain Vision, Life insurance, Temporary disability, Long-term disability, Accidental death and dismemberment, Accident, Critical illness, Hospital indemnity claims incurred under the terms of the plan. The total premiums paid for the plan year ending 09/30/2025 were \$1,318,855.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was -\$2,151,994 as of the end of plan year, compared to -\$161,188 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of -\$1,990,806. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$25,923,170 including employer contributions of \$22,103,708, employee contributions of \$2,395,462, gains/(losses) of \$0 from the sale of assets, and earnings from investments of \$0. Plan expenses were \$27,913,976. These expenses included \$1,927,558 in administrative expenses, \$25,986,418 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
